

Product Highlights

This product provides assistance in the event of a vehicle loss and is suitable whether the vehicle is financed, leased or paid in cash. In the event of a vehicle loss, an in-store loyalty credit can be redeemed at the selling dealer.

Privilege Options

Negative Equity Privilege

If the customer's vehicle is stolen or damaged and declared a total loss, they will be eligible to receive an instore loyalty credit towards a replacement vehicle in an amount equal to the value of the vehicle and the remaining loan balance.

Total Loss Event Privilege

If the customer's vehicle is stolen or damaged and declared a total loss, they will be eligible to receive an instore loyalty credit towards a replacement vehicle purchase.

Theft Event Privilege

If the customer's vehicle is stolen and not recovered, they will be eligible to receive an in-store loyalty credit towards a replacement vehicle purchase.

Partial Loss Event Privilege

If the customer's vehicle is damaged and repaired, resulting in a damage record on their vehicle's history report, they may be eligible to receive an in-store loyalty credit at the time they purchase a replacement vehicle.
